Kangaroo Valley Chamber of Tourism and Commerce Photo Competition Terms and Conditions of Entry

1. This competition is open to all residents of, and visitors to, Kangaroo Valley.
2. Entries will only be accepted by email (to: competition@visitkangaroovalley.com.au) and in JPEG format (up to 5MB).
3. All entries must be accompanied by the official Entry Form (one photo per Entry Form).
4. Five entries per entrant permitted.
5. Entrants under the age of 18 years must have approval of a parent or legal guardian.
6. Photos must be taken within Kangaroo Valley or have Kangaroo Valley as its primary subject.
7. The image must have been created in the season for which the entry is submitted.
8. Content of an inappropriate or offensive nature is not permitted.
9. If a photo shows a person/people, by submitting the photo to this competition the entrant is stating that they have the permission of the people shown in the entered photo to include them in the photo, and that they have no objections to the photo being published or used in any medium for any purpose. If taking a photo of a person under the age of 18, permission from their parent/legal guardian must be obtained.
10. Photos must be natural looking – photos that have been enhanced or altered, such as photoshopped images, will not be accepted. Minor adjustments such as sharpening, contrast, cropping are acceptable.
11. By entering this competition, the entrant is stating that they are the creator of the image and own the copyright of the image.
12. This competition is being run by the Kangaroo Valley Chamber of Tourism and Commerce (the Chamber).
13. All entrants give the Chamber (and its subsidiaries) permission to reproduce any submitted images on its website, social media sites and/or in any future material produced by the Chamber for promotion, advertising or marketing purposes. Use of a photo by the Chamber will be free of charge and photo credit will be given where possible.
14. Members of the Chamber Committee are permitted to enter this competition, however they are not eligible to win any prizes.
15. The competition winners will be selected by the Committee of the Chamber. The decision of the judges is final and no further correspondence will be entered into.
16. Entries will be judged on portrayal of Kangaroo Valley scenery, activities, events, and/or are the most original, interesting and appropriate for publication.
17. The judges will select one winner and one runner-up for each season, and one overall winner for the best series of photos (covering one photo from each season). The judges reserve the right to not award a prize if they do not have a worthy recipient.
18. The entrant indemnifies the Chamber against any claim, legal or otherwise, that may arise out of publication of the image.
19. This is not a game of chance.
20. All information detailing how to enter forms part of these terms and conditions. Submission of an entry will be taken to mean acceptance of these terms and conditions.
